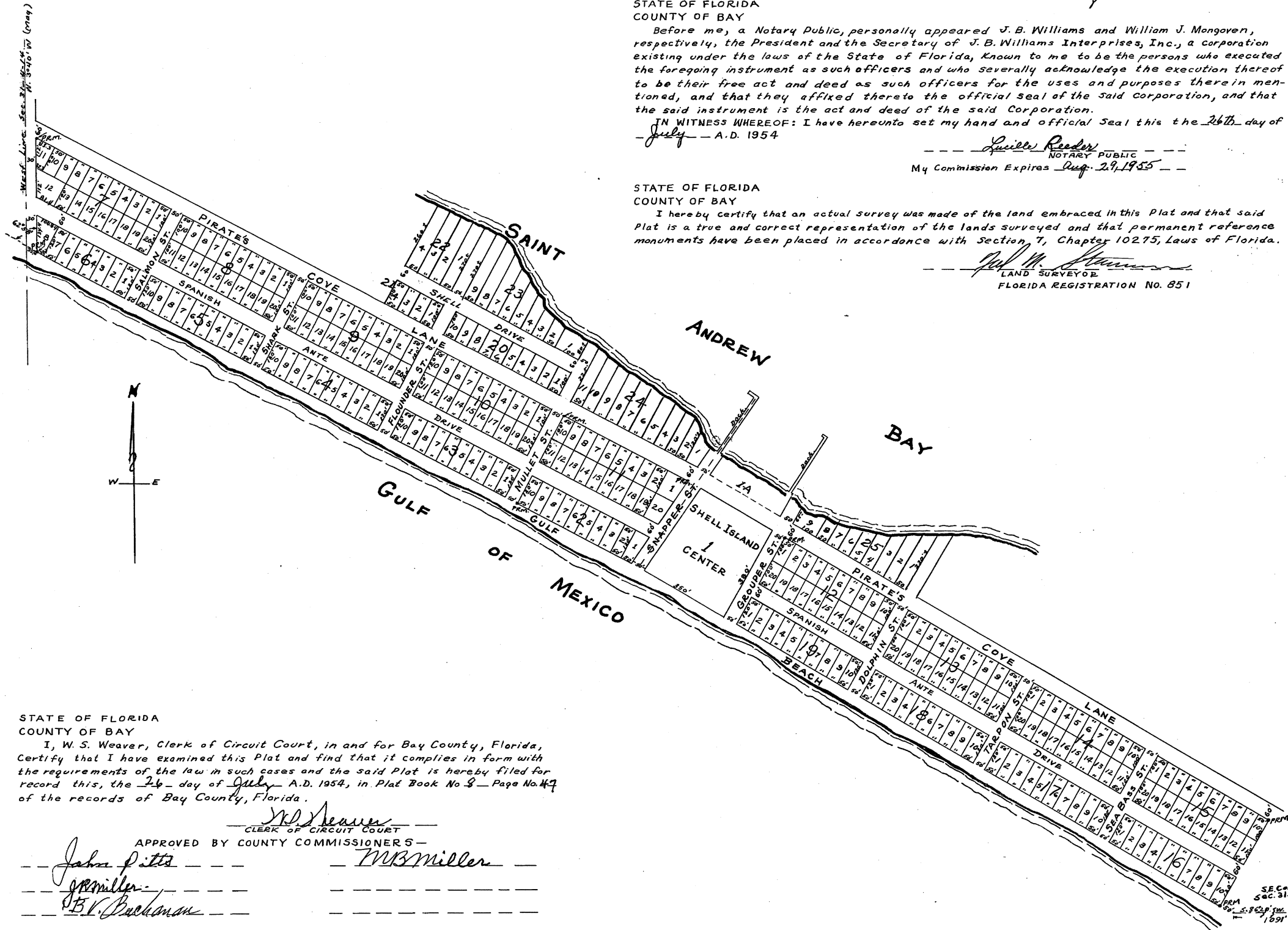


SPANISH ANTE
